1. Question: Note 5, under HVAC Construction Notes states "Outside Air Dampers shall have low leakage shut off dampers with motorized operations." The drawings never reference any outside air, louvers, or motorized dampers. Is the intent to have outside air to the unit and if so what is the size and location?
 1. Answer: No outside air damper or duct is specified and the HVAC construction note will not apply to this project.
2. Question: The unit is larger than 2000 CFM, should the duct detector be included and tied into the fire alarm system? If so, what type of system is it & is there proper space for this connection?
 2. Answer: It is not our intention at this time to renovate the fire alarm system in this building. It may be done at a later date under a full building renovation project.
