The finish scheduled also references the existing glazed CMU's as the base in the sleeping rooms. One of the Mason's that has done a number of these buildings indicated that sometimes they have used the glazed units on the new exterior walls and sometimes they don't. Please verify that the glazed CMU is not to be used on the new exterior (front) walls.
