1. Q: Is it the intent to have coil coatings on AC-1?
1. A: No, Coil coating is not required.

2. Q: The current Control Sequence of Operation of existing AC-1 is unknown. Please provide a Control Sequence of Operation for the new AC-1.
2. A: There is no control sequence of operation per se. There is an independent manual fresh air intake control circuit. It will remain as is. The new AC-1 is a stand alone heat pump controlled by a digital thermostat.
